- 3. Subhauler further represents and warrants that he/she is the holder of all the necessary state and/or federal certificate, permits, or licenses, which are required by law for him to conduct business as a hauler contractor, and

that he/she has registered by law with the appropriate collector of internal revenue authorizing him to operate under highway use tax.

- 4. Subhauler further represent that he is fully protected by minimum of
  - a. \$1,000.000 Auto Liability Insurance Coverage
  - b. \$1000,000 Cargo Insurance
  - c. \$50,000 physical damage coverage on any unidentified trailer

and will continue in effect said coverage while acting as subhauler during the term of this agreement.

- 5. The carrier shall notify the subhauler of the product to be transported, time and location of the place to load, all within a reasonable time prior to the date with all reasonable diligence, cause such product and that delivery required. Thereafter the subhauler shall, without delay, cause said property to be transported to the place designated by the shipper, or its representative.
- 6. Carrier will be paid by load whenever the subhauler agrees with the rate.
- 7. This agreement can only be amended or changed in writing executed by all parties and will be enforced until canceled in writing by either party.

#### Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

· Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
